ADOPTED LOCAL LAWS OF 2023

LOCAL LAW NO. 4 OF 2023

A LOCAL LAW TO UPDATE AND AMEND CHAPTER 33 OF THE TOWN CODE OF THE TOWN OF CHESTER TO PROHIBIT SMOKING, VAPING, AND THE USE OF ELECTRONIC CIGARETTES ON PUBLIC PROPERTY

ELECTRONIC CIGARETTES ON PUBLIC PROPERTY

It is the intent and purpose of this Local Law to update and amend Chapter 33 of the Town Code of the Town of Chester, entitled "Alcoholic Beverages and Cannabis," to add provisions which prohibit smoking, vaping and the use of electronic cigarettes on public property located in the Town of Chester. It is the finding of the Town Board of the Town of Chester that smoking, vaping, and the use of electronic cigarettes on public property owned by the Town of Chester is detrimental to the health, safety and welfare of the citizens of the Town of Chester, and that such public use contributes to the creation of nuisances and otherwise impedes upon the welfare of Town residents. The Town of Chester enacts this local law an exercise of its police power to promote the general health, safety and welfare of the residents of power to promote the general health, safety and welfare of the residents of the Town of Chester.

LOCAL LAW NO. 5 OF 2023

A LOCAL LAW TO FURTHER UPDATE AND AMEND CHAPTER 87, ARTICLE VI, OF THE TOWN CODE OF THE TOWN OF CHESTER TO AUTHORIZE PROPERTY TAX EXEMPTION TO VOLUNTEER FIRE FIGHTERS AND VOLUNTEER AMBULANCE WORKERS WHO HAVE ACCUMULATED AT LEAST TWO YEARS OF SERVICE

It is the intent and purpose of this Local Law to further update and amend Chapter 87, Article VI, of the Town Code of the Town of Chester, entitled "Exemption for Volunteer Emergency Personnel," to grant a partial real property tax exemption to qualifying volunteer firefighters and volunteer ambulance who have accumulated at least two years of service.

LOCAL LAW NO. 6 OF 2023

A LOCAL LAW TO UPDATE AND AMEND CHAPTER 87, ARTICLE I, OF THE TOWN CODE OF THE TOWN OF CHESTER TO ADJUST THE SENIOR CITIZEN REAL PROPERTY TAX EXEMPTION IN ACCORDANCE WITH NEW YORK STATE REAL PROPERTY.

It is the intent and purpose of this Local Law to update and amend Chapter 87, Article I, of the Town Code of the Town of Chester, entitled "Senior Citizens Tax Exemption" to increase the exemption limits to the maximum income ceiling permitted for senior citizens residing in the Town of Chester, County of Orange, State of New York, as authorized by New York State Real Property Tax Law §467.

LOCAL LAW NO. 7 OF 2023

A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW SECTION 3-C

It is the intent of this Local Law to override the limit on the amount of real property taxes that may be levied by the Town of Chester, County of Orange, State of New York (hereinafter "Chester") pursuant to General Municipal Law §3-c, and to allow Chester to adopt a town budget for (a) town purposes and (b) any other special or improvement district governed by the Town Board for the fiscal year 2024 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

Stops throughout Chester &Goshen, including Coach Bus Depots. Regularly scheduled stops on Tuesdays and Thursdays at Chester ShopRite. Special stop at Quick Check in Florida. Transfers available in Warwick for Middletown.

BURNING OF BRUSH AND LEAVES

Brush and leaves are <u>NOT</u> allowed to be burned from <u>March 16th</u> through <u>May 14th</u> annually. A local permit is not required. Refer to NYS Dept. of Environmental Conservation 6 NYCRR Part 215.2 for detailed information, prohibitions, exceptions and restrictions.

BRUSH DISPOSAL

Brush, which includes branches and twigs up to 8" wide, can be disposed of at the Town of Chester Highway Garage, 77 Laroe Road. NO LEAVES or GRASS CLIPPINGS ALLOWED! Permit is free to all residents and may be obtained Monday-Friday, 7:30—3:30 pm.

E-RECYCLING DROP OFF & BULK PICK UP

E-recycling is available at IWS, 89 Black Meadow Road Monday – Friday from 8:00 am – 4:00 pm. <u>I.D. required.</u>

PEDDLING, SOLICITING & DO NOT KNOCK REGISTRY

A Local Law amending & replacing Chapter 71 entitled "Peddling and Soliciting" of the Code of the Town of Chester, said Chapter to be renamed "Peddling, Soliciting and Do Not Knock Registry" was enacted by the Town of Chester in 2018. This local law prohibits peddling & the soliciting of Chester Town residents who register with the Town Clerk.
