REAL ID

Beginning May 7, 2025, if you plan to use your state-issued ID or license to fly within the U.S., make sure it is REAL ID compliant.

Barring any further delays, REAL ID will go into effect on May 7, 2025. At that point, US travelers 18 and older will need a REAL ID-compliant driver's license, identification card, state-issued enhanced driver's license (EDL), or another acceptable form of ID to fly within the United States. REAL IDs also will be needed to access certain federal facilities.

VALID "REAL ID" IDENTIFICATION

Adult passengers 18 and older must show valid identification at the airport checkpoint in order to travel.

- Driver's licenses or other state photo identity cards issued by Department of Motor Vehicles (or equivalent)
 - Beginning May 7, 2025, if you plan to use your state-issued ID or license to fly within the U.S., make sure it is REAL ID compliant. If you are not sure if your ID complies with REAL ID, check with your state department of motor vehicles.
- U.S. passport
- U.S. passport card
- DHS trusted traveler cards (Global Entry, NEXUS, SENTRI, FAST)
- U.S. Department of Defense ID, including IDs issued to dependents
- Permanent resident card
- Border crossing card
- State-issued Enhanced Driver's License
- An acceptable photo ID issued by a federally recognized, Tribal Nation/Indian Tribe
- HSPD-12 PIV card
- Foreign government-issued passport
- Canadian provincial driver's license or Indian and Northern Affairs Canada card
- Transportation worker identification credential
- U.S. Citizenship and Immigration Services Employment Authorization Card (I-766)
- U.S. Merchant Mariner Credential
- Veteran Health Identification Card (VHIC)

REAL/ENHANCED DRIVER'S LICENSE

Orange County Mobile DMV Unit will be at Chester Town Hall on November 28, 2023 to offer this service and others as listed on the attached flyer.

DOCUMENTS NEEDED FOR A REAL ID OR ENHANCED ID - (Must be all original documents.)

1 Birth Certificate or Passport (passport cannot be expired)

If you are female, and the last name is different than the last name on the birth certificate.

You need to bring in a marriage certificate or divorce decree.

2 Social Security Card, or W2 from your employer, or 1099.

3 Current Driver License or Non-Driver ID.

2 proofs of NYS Residency (no post office box as address)

Bank Statement

Utility Bill

Paystub

Major credit card bill

Property tax bill

Property deed

Rental lease agreement

NYS pistol permit

What happens if I don't have a REAL ID by the deadline and am flying domestically?

Once the act goes into effect, a state driver's license or ID that does not contain a REAL ID seal will no longer be accepted at airport security checkpoints across the country. If you don't have a REAL ID-compliant driver's license, an EDL, or another acceptable form of identification, you will not be permitted to enter the TSA security checkpoint and will not be allowed to fly.
