During the month of January 2025, the Town of Chester Police Department responded to 11 animal complaints and investigated 6 motor vehicle crashes involving a deer. A breakdown of the complaints for the month is included below:

- 5 of the calls for service were for loose, lost or found dogs
- 2 of the calls for service were for injured or deceased deer
- 1 of the calls for service was for a sick cat
- 1 of the calls for service was for a fox sighting
- 1 of the calls for service was for a possibly injured coyote
- 1 of the calls for service was for a deer stuck on the ice
