During the month of May 2025, the Town of Chester Police Department responded to 19 animal complaints and investigated 4 motor vehicle crashes involving a deer. A breakdown of the complaints for the month is included below:

- 6 of the calls for service were for loose, lost or found dogs
- 2 of the calls for service were for bear sightings
- 2 of the calls for service were for turtle sightings
- 2 of the calls for service were for welfare checks on a dog
- 1 of the calls for service was for an injured deer
- 1 of the calls for service was for an injured raccoon
- 1 of the calls for service was for an injured goose
- 1 of the calls for service was for a found fawn
- 1 of the calls for service was for found baby rabbits
- 1 of the calls for service was for a rattlesnake on a pool cover
- 1 of the calls for service was for a turkey that flew through a house window
