Report of Police Department for June 2025

The Town of Chester Police Department remained active in the community in June. We continued to maintain our objective of community commitment, while taking a proactive stance towards detecting crime and enforcing the laws. In June, the police department responded to **296 calls for service**. Officers drove **15,144 miles** during the month.

A breakdown of the criminal and non-criminal activity for the month is included below:

CRIMINAL ACTIVITY

The Town of Chester Police Department made 12 arrests during the month. A summary of the arrests is as follows:

- 6 charged with Operating a motor vehicle with a Suspended Registration or Suspended Driver License
- 1 charged with Criminal Contempt of a Court Order in the second degree
- 1 charged with Endangering the Welfare of a Child
- 1 charged with Aggravated Driving While Intoxicated and Driving with a BAC greater than .08%
- 1 charged with Dog at Large
- 2 taken into custody for Emergency Admissions of the Mentally III

NON-CRIMINAL ACTIVITY

In addition to the arrests listed above, officers also responded to other calls for service in May. A summary of those calls for service is as follows:

- 31 medical calls
- 12 residential, commercial or automatic fire alarms
- 19 reports of suspicious persons, vehicles or activity
- 9 domestic disputes, disturbances or other disputes
- 7 motor vehicle crash with injuries
- 8 motor vehicle crashes without injuries
- 1 motor vehicle crashes involving deer

COMMUNITY POLICING

During the month, Town of Chester police officers assisted members of the community in many ways. Some of the community policing activity is listed below.

Officers completed 9 house security checks and 1016 business security checks in June.

Sergeant Dugan and Officers Bird, Weinstein, Stack and Narain continue to complete child passenger safety seat checks and installations when needed. There were no seats check completed in June.

The PBA Touch-a-Truck event was scheduled for June 7th, but was cancelled that morning due to inclement weather.

Officer Stack remained in contact with Senior Center staff and members of the seniors' group.

Officer Gundermann conducted a tour of the police station for a group of brownies from a local Girl Scout Troop on tune 10th.

TRAINING

Officer Stack attended the Taser Instructor Recertification class on June 5th and 6th.

Officer Calderone assisted as a Firearms Instructor at a state Firearms Instructor course in Goshen on June 11th.

Officer Calderone attended the state Aerosol Subject Restraint Instructor course on June 16th and 17th at the police academy in Middletown.

Semi-annual firearms training continued in June at the county range in Goshen.

MISCELLANEOUS

Chief Doellinger attended a meeting and a press conference on June 3rd with NYS Assemblywoman Paula Kay in Middletown regarding some criminal justice reform measures that she was involved in passing and others under review.

On June 5th, Chief Doellinger, Administrative Sergeant Vitale and Sergeant Chambers attended the quarterly meeting on the NYS Accreditation Council in Albany. The department received a Certificate of Accreditation from the council. Sgt. Chambers received an award for his work as the department's Program Manager.

Community Commitment

On June 8th, Officer Nicholas Contino responded to a rollover motor vehicle crash on Kings Highway around 4am. He arrived to find a vehicle on fire with the operator trapped inside. He broke the sunroof on the vehicle and removed the operator with the assistance of a passing motorist and another first responder, most likely saving her life.

Commercial vehicle enforcement details were held on June 12th and 17th with the NYS Department of Transportation. Ten vehicles were inspected and six unsafe vehicles were taken out of service with major violations.

Chief Doellinger attended a family barbeque event at the Fox Hill Bruderhof Community on June 21st.

An officer was assigned to transport the ballot bag to the Board of Elections in Goshen at the close of the primary election polls on June 25th.

Chief Doellinger attended the HS Graduation Ceremony at the Chester Academy on June 26th. Officers were assigned to work during the event for security and traffic control assistance.

We continued to provide School Resource Officers to the Chester Union Free School District. Officers Perez, DeLuca and Donato were assigned to provide coverage at the Chester Academy and the Chester Elementary School.

SCHEDULING

There were 372.25 hours of overtime paid in June.

Part-time police officers were used for 176 hours of patrol coverage (168 regular hours and 8 overtime hours).
