RE: Report of Police Department for July 2025

The Town of Chester Police Department remained active in the community in July. We continued to maintain our objective of community commitment, while taking a proactive stance towards detecting crime and enforcing the laws. In July, the police department responded to **304 calls for service**. Officers drove **15,105 miles** during the month.

A breakdown of the criminal and non-criminal activity for the month is included below:

CRIMINAL ACTIVITY

The Town of Chester Police Department made 9 arrests during the month. A summary of the arrests is as follows:

- 4 charged with Operating a Motor Vehicle with a Suspended Registration or Suspended Driver License
- 1 charged with Criminal Obstruction of Breathing and Harassment in the second degree
- 1 charged with Performing an Unlawful Eviction
- 1 charged with Soliciting without a Permit
- 1 charged with Harboring an Unlicensed Dog
- 1 taken into custody for Emergency Admissions of the Mentally III

NON-CRIMINAL ACTIVITY

In addition to the arrests listed above, officers also responded to other calls for service in July. A summary of those calls for service is as follows:

- 32 medical calls
- 23 residential, commercial or automatic fire alarms
- 16 reports of suspicious persons, vehicles or activity
- 14 domestic disputes, disturbances, disorderly persons or other disputes
- 0 motor vehicle crashes with injuries
- 6 motor vehicle crashes without injuries
- 3 motor vehicle crashes involving deer

COMMUNITY POLICING

During the month, Town of Chester police officers assisted members of the community in many ways. Some of the community policing activity is listed below.

Officers completed 36 house security checks and 1036 business security checks in July.

Sergeant Dugan and Officers Bird, Weinstein, Stack and Narain continue to complete child passenger safety seat checks and installations when needed. There were two seat checks completed in July.

TRAINING

Officer Calderone assisted with firearms instruction at the police academy on July 7th.

MISCELLANEOUS

Officers were assigned to foot and bicycle patrols, as well as traffic direction posts, for the annual town Block Party and Fireworks event on July 12th. The event was very well attended and no major problems or issues occurred.

Tactical Response Unit officers were assigned to assist Monroe and Greenwood Lake with their fireworks events on July 3rd and July 5th.

Commercial vehicle enforcement details were held on July 1st and 15th with the NYS Department of Transportation. Eleven vehicles were inspected and six unsafe vehicles were taken out of service with major violations.

SCHEDULING

There were 371.25 hours of overtime paid in July.

Part-time police officers were used for 168 hours of patrol coverage (168 regular hours and no overtime hours).
