RE: Monthly Report for Animal Control for August 2025

During the month of August 2025, the Town of Chester Police Department responded to 24 animal complaints and investigated 3 motor vehicle crashes involving a deer. A breakdown of the complaints for the month is included below:

- 11 of the calls for service were for loose, lost or found dogs
- 4 of the calls for service were for sick or injured raccoons
- 3 of the calls for service were for injured or deceased deer
- 2 of the calls for service were for a deceased or injured goose
- 2 of the calls for service were for bear sightings
- 1 of the calls for service was for a snake in a house
- 1 of the calls for service was for a person bitten by a cat
