**RE: Report of Police Department for September 2025**

The Town of Chester Police Department remained active in the community in September. We continued to maintain our objective of community commitment, while taking a proactive stance towards detecting crime and enforcing the laws. In September, the police department responded to **236 calls for service**. Officers drove **15,728 miles** during the month.

A breakdown of the criminal and non-criminal activity for the month is included below:

### CRIMINAL ACTIVITY

The Town of Chester Police Department made **8 arrests** during the month. A summary of the arrests is as follows:

- 1 arrested on an outstanding arrest warrant
- 1 charged with Possession of a Forged Instrument in the third degree
- 1 charged with Driving While Intoxicated
- 1 charged with Driving While Ability Impaired by Drugs and Operating with a Suspended Driver License
- 2 charged with Disorderly Conduct
- 1 charged with Dog at Large and Failure to License a Dog
- 1 taken into custody for Emergency Admissions of the Mentally Ill

### NON-CRIMINAL ACTIVITY

In addition to the arrests listed above, officers also responded to other calls for service in September. A summary of those calls for service is as follows:

- 27 medical calls
- 15 residential & commercial burglary or fire alarms
- 11 reports of suspicious persons, vehicles or activity
- 11 domestic disputes, disturbances, fights, or other disputes
- 0 motor vehicle crashes with injuries
- 3 motor vehicle crashes without injuries
- 0 motor vehicle crashes involving deer

## COMMUNITY POLICING

During the month, Town of Chester police officers assisted members of the community in many ways. Some of the community policing activity is listed below.

Officers completed **1 house security check and 1136 business security checks** in September.

Sergeant Dugan and Officers Bird, Weinstein, Stack and Narain continue to complete child passenger safety seat checks and installations when needed. There were two seat checks completed in September.

Officer Dunlop maintained contact with the Bruderhof Bellvale Community. They will be holding their annual Fall Festival on October 4<sup>th</sup>.

Sgt. Vitale maintained contact with the Sugar Loaf Chamber of Commerce. Discussions were initiated regarding their annual Fall Festival scheduled for October 11<sup>th</sup> and 12<sup>th</sup>.

## TRAINING

Departmental monthly training was held on September 9<sup>th</sup> in our training room.

Officer Calderone assisted with firearms and OC spray instruction at the police academy for four days in September.

Officer Calderone attended the annual TRU weeklong training beginning on September 29<sup>th</sup>.

Semi-annual firearms qualifications began in September at the range in Port Jervis.

## MISCELLANEOUS

Chief Doellinger and on-duty officers attended the annual 9/11 Remembrance Ceremony at the memorial site in Carpenter Community Park on September 11<sup>th</sup>.

Officer Gundermann staffed a table with information about the police department and some of our community programs during the town's Field Day held in the Chester Commons Park on September 28<sup>th</sup>.

Chief Doellinger, Administrative Sgt Vitale and Det Slaughter attended the Senior Picnic at the Sugar Loaf Performing Arts Center on September 30<sup>th</sup>.

Officers performed foot patrols during a high school football game at the Chester Commons Park on September 26<sup>th</sup>.

Commercial vehicle enforcement details were held on September 2<sup>nd</sup> and 16<sup>th</sup> with the NYS Department of Transportation. Nine vehicles were inspected and three unsafe vehicles were taken out of service with major violations.

Officers Calderone and DeLuca assisted the Village of Goshen PD with a large gathering vigil on September 15<sup>th</sup>. Officer Dunlop and K9 Lou performed a pre-event explosives detection sweep.

School Resource Officers Santosky-Wright, DeLuca and Donato returned to the Chester Academy and Chester Elementary Schools in September. The students returned to school on September 3<sup>rd</sup>.

## SCHEDULING

There were 368 hours of overtime paid in September.

Part-time police officers were used for 208 hours of patrol coverage (208 regular hours and no overtime hours).
