RE: Monthly Report for Animal Control for June 2026

During the month of June 2026, the Town of Chester Police Department responded to 16 animal complaints and investigated 5 motor vehicle crashes involving a deer. A breakdown of the complaints for the month is included below:

- 3 of the calls for service were for loose, lost or found dogs
- 2 of the calls for service were for injured or deceased deer
- 2 of the calls for service were for a possibly injured bear
- 2 of the calls for service were for possibly abandoned fawns
- 1 of the calls for service was for a bear sighting
- 1 of the calls for service was for a skunk in the driveway
- 1 of the calls for service was for a snake in the basement
- 1 of the calls for service was for a found domestic rabbit
- 1 of the calls for service was for a deceased cat on the road shoulder
- 1 of the calls for service was for two dogs fighting
- 1 of the calls for service was for a deer that fell into a window well
